- Activity performed today

It was my first day of field work and I was very happy to work with ARZ especially about Commercially Sexual Exploitation which I was not aware about. I reached ARZ at 9:45am as Ms. Juliana asked me to report at 10:00am. Ms. Juliana showed all the rooms in the office, Arun Sir has entered and introduced himself to me. Ms. Juliana took a session about ARZ, how it functions, what is sexual trafficking, the laws related to sexual trafficking, about child sexual abuse, commercial sexual abuse; during the session she asked me many questions to check how much I am aware about the work I'm going to handle for the rest of the days. Ms. Juliana also explained about the Bauma area; about the State protective home in goa & how it works and how ARZ is connected with State protective home. I learnt that based on the case details prepared by ARZ of the rescued victims The adult victims are kept at the state protective home established under Section 21 of Immoral Traffic (Prevention) ACT 1956 and the victims who are minors in age are

are kept at the government children's home, "Apna Ghar", established under the Juvenile Justice (Care and protection of children) Act, 2000. The victims are rescued from CSE by the Goa police, only the police have the authority to rescue the victims and they are admitted only at Government shelter homes. Ms. Juliana also guided me about the one stop center and the work one stop center does. She introduced me to Bimawsa Chalwadi, I was not able recognize her but later I remembered reading an Article where she received an award "CII women Exemplary Award 2019 for education". Ms. Bimawsa also transformed lives of Goan girls at risk of sexual Exploitation. Ms. Bimawsa took me for a Baina visit. I learnt that Baina was an organised red light area next to Baina beach in Vasco, in June 2004 houses and brothels in the red light area were demolished by the Goa State Government. Where the women from Karmabina, a neighboring slum area and from the states of Karnataka and Andhra Pradesh were trafficked for commercial sexual exploitation. So I found many ^{speaking} Kannada talking people in Baina. A majority of these women were minors and got settled in Baina itself. In September 2006, APZ started a shift wash, a laundry unit for the economic rehabilitation of women in prostitution. But when I went to see the shift wash & asked about it to Bimawsa, she told that due to the covid situation they shut down the.

shift work due to financial issues. Bimawa guided me to note few phone numbers from Baina area who wants to receive their Voter ID. We went to few houses to check whether they have received the Voter ID. Some people were verified through phone calls. Ms. Bimawa took me to Head of Taluka Revenue office to collect the Voter ID for some of the community people. Learnt about the Supreme Court case to issue Aadhar Card, Voter ID, Ration card for the sex workers and learnt that it's a fundamental right and Right to dignity.

Attended a period Hygiene awareness session with the children of Baina conducted by Lunida. Lunida told me to calculate some accounts which is related to a new project (stitching project). I have learnt how the NGO works, how to conduct a session, how to talk to children and the way they understand what we teach.

Learnt what kind of opportunities can be created for the community people. Different organisations bring up new ways to help them like giving these people with wool clothes that are then recycled into various products like stitching cushion covers, bags etc., learnt how they will rescue the victims in a theoretical and legal way provisions. The stages of commercial sexual exploitations, Resistance, adaptation and acceptance. Ms. Juliana also explained me that in the 1st stage, the victim

will be with 24 hrs security, chance of exit for the victims are around 1 to 2%. The victim at this stage can be rescued only by police but NGO's & customers may help but as there are too much of security it very hard to rescue the victims. They also do not earn anything at that stage. The second stage of adaptation there are 20% - 50% chance for rescue but as they have faced violence & sexual exploitation at 1st stage it is very hard for them to believe someone. In the stage of acceptance there are 50% - 60% chances, as the selling network (or) agent who brought them to the place start believing them and they also start earning more so they will think many times to come out of the sex work. HS Juliana gave ^{me} a task for me to read the book "Beautiful women" and asked me to discuss about one women & analyse the same. I had a great experience with ARZ on my first day; Even when language was a barrier I enjoyed the things which I have learnt in my 1st day.

- Observation related to Agency, services, delivery etc:

The way ARZ maintain their A/C's book, the discussion which they had in the morning and at the end of the day, I was not a part of it as the meeting was an employee meeting. The task which is assigned to each person RACHANA is followed by the team.

- Activity Performed Today :

SWIFT

MS Juliana guided me to work with Ms. Annapurna Rayput, a community worker + Shuttle wash supervisor and was working in ARZ for past 13 years. I felt so comfortable working with her, she communicated with me in telugu and asked me to learn Hindi, I reached the field work at 9:45am. Ms. Annapurna asked me to calculate the list of provisions which ARZ is giving to the community people. The list had 5kg Rice, 2kg Sugar, 5 soap, 10 Biscuits, etc., the list was for 10 people. They guided me to calculate all the budget for the provisions which is given to the sex workers in the nearby slum area. Ms. Annapurna took me to Hangalp hills and guided me about the area. After the abolition of the red light area in 2004, many of the sex workers moved to the nearby slum areas, one of the slum is Hangalp hills. There were many children who surrounded Ms. Annapurna and she conducted a game called "JANDI, KHETO, JETTO" movement game which was very interesting, it was played like the "SNAKE + LADDER" game. The game had many cards.

One team has to pick a card and answer the question which is written in the card, it was like a awareness session which had questions about age of marriage, good touch & bad touch [safe & unsafe touch] etc. I learnt how to conduct a awareness session through a game. Traveled to 'Fakir Gali' which is the slum area nearby, Ms. Annapurna took guided me about the area and we visited a sex workers place confidentially. When we visited, her daughter was cooking and talking with Ms Annapurna in Kannada. She discontinued her education due to economic condition as her mother is still in sex work. She is vulnerable due to the surrounding she is brought up, ARZ is trying to put her up in the boarding school but her mother is not allowing to continue her schooling. Seeing the sex workers on the road at night, dressed up but with the family they were very normal. Visited two more sex workers who requested to provide them for the ration, one Client's son met with a accident & we had a conversation with their family. I was assigned a task to do a warranty registration for a speaker which we provided to State Protective Home, Hennur. The speakers were provided by ARZ for the victims who are in SPH, as the victims are not allowed to go outside ARZ thought if they provide a speaker, so that it will be relaxing for the victims.

Ms. Juliana took me to a government School New Vaddam where they conducted a awareness session, mom took me to receive the fee for the awareness session for the children in the school.

Activity performed today :

As soon as I reached ARZ at 9:50am, Ms. Annapurna explained me to type Social Investigation Report, showed me some reports & client details. Social Investigation Report which is prepared for a child which is in need of care and protection and sent to child welfare committee, in ARZ the report was prepared to send the children for boarding school as they don't have good environment to study. The typing of Social Investigation report was completed at 1:00pm. The social Investigation Report had details of parent of the child, in which STD + school they are studying; observation of the report. Did a study on trafficking of Women & Children for commercial sexual Exploitation (CSE) in Goa; A statistical Analysis (2014 to 2019). As I have heard before the majority of the clients are domestic tourists, the main form of sexual activity which is happening commercially.

is hotel and lodge based, followed by massage parlor and flat based. Learnt many things which was like a awakening for me; Post rescue detention at protective home for 21 days (for victims), which is enquired by the magistrate, calling family members for inquiry. The age group of the victims are ranging from 21 to 35 yrs. It was very useful and had a clarity after reading the book. There were majority of rescued victims who accepted that they were involved in CSE [88.25% Accepted; 11.75% Not accepted]. Most of the rescued women were from Indians and 15.8% were foreigners which I was not aware about, the myth was there are so many foreigners who are involved in sexual commercial exploitation. Had a statistical clarity about state distribution of victims. Relationship with traffickers are mostly known and there are very less percentage of unknown victims who are trafficked. The causes of trafficking are mostly because of Job, Financial problem, home and victims are sold; Marriage, human & kidnapping comes the next. Learnt that majority of the victims were rescued by the police who were successful in rescuing the girls.

- There are very few instances where self rescue as a victim is completely under the control of the traffickers. Mostly Rural Area people are vulnerable to commercial sexual exploitation.

It is clearly shown that lack of development & inadequate income earning options particularly in rural areas as compared to urban areas which create vulnerability to CSE. Where religious wise majority statistical study may very new to me, Hindu & Muslims were high. Marital status of victims ; Educational wise distributions of victims ; Family structure & distribution of victims ; Family situation. As reflected in low literacy levels the lack of skills & education makes the girls women victims of commercial sexual exploitation particularly as they support family members. It is generally found that the traffickers identify vulnerable girls build relationship with them & then traffic them ; Nature & services which are requested for rehabilitation which include shelter, job, protection, education for children, Health services payment of loan. Nature of service requested for rehabilitation like shelter, Job opportunity, education for children, health services, payment of loan, Retrieval of property. There was so many information which I was not aware about and learnt everything.

The residents shared the drawbacks of SPH and what are necessary things they want in SPH. The report had Issues relating to Food, Cleanliness, clothes and other issues. Learned how SPH is functioning and the thoughts of the people inside the home. Sofira gave me a task to collect the news paper article of ARZ and read ^{most of} the news related to ARZ & also Sofira guided me to fill the organisation profile which

was useful for my course. Ms. Sofira assigned me a task to type a report about child sexual abuse and Human trafficking. The session was held in Father Agnel's Hr. Sec School Noida on 2nd March 2022. The session was about who is a child; age of the child; child private parts of the child, they also discussed about the POCSO Act for legal awareness, Direct & Indirect forms of abuse, Stages that lead to child sexual abuse, Prevention of online child sexual abuse, about the helpline number, types of human trafficking was also discussed. learnt about the cyber crime cell which takes action when complaint is given online. Sofira cleared my doubt about whether transgender are kept in state protective home and it was good to know that they are kept in state protective home. By the task assigned last week about the 1st time voting of transgender in goa [to make a documentary regarding the same], was very useful & shocking for me to know that they have voted for the 1st time after 30 to 40 years being in goa and learnt how much work ncp has done for them.

The 1st speaker talked about how important the constitution is and how the students from law should give importance to constitution. The part of ARZ is the speech was about proving voter ID for the 1st time and their were 1st time voters and there were many transgenders who were speakers who travelled from ARZ. The speakers shared about the struggle to get their voter ID. The basic fundamental rights for all the citizen were not given to them. The 1st time voters were around 30 years and they were lived in the place for more than 20 years without the voter ID.
