ORDER

- A) The duration of the project shall be of one year. The extension of the project will be allowed only with the consent of the Directorate of Higher Education. A written request in this regard must be sent to the Directorate of Higher Education.
- B) The amount of Rs. 1,00,000/- each shall be disbursed to the above three Research Experts to carry out the said Research project. 60% of the financial assistance will be provided as a first instalment to each Research Expert at the beginning of the project.
- C) The balance 40% of the amount will be released upon submission of the utilization certificate of the first instalment and the progress report by each Research Expert.
- D) Each expert is required to submit a six-monthly progress report to the Directorate of Higher Education.
- E) Upon completion of the project or at the end of one year of the project (except in the case of the project extension), a final project report must be submitted to the Directorate of Higher Education.

- i) In order to disburse the amount to each Research Expert, they should submit the pre-receipt of Rs. 60,000/- each to the Directorate of Higher Education to release the first instalment.
- G) After submitting the utilization certificate and progress report of the first instalment by each Research Expert, they should submit the pre-receipt of Rs. 40,000/- each to the Directorate of Higher Education to release the second instalment.
