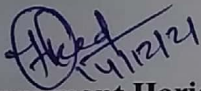

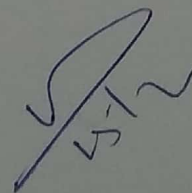
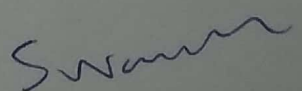

APPOINTMENT ORDER

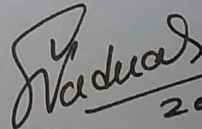
