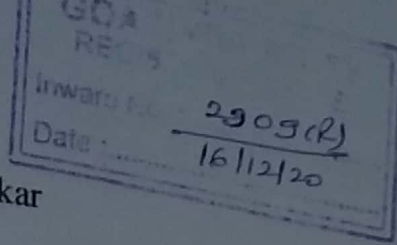

APPOINTMENT ORDER


WHEREAS, **Mr. Kedar Umakant Narvekar** has accepted the terms and conditions mentioned in the offer of Appointment issued vide No.GU/Admn.(T)/2020/1460 dated 01/12/2020 for the post of **Assistant Professor** (OBC Category) in Inorganic Chemistry in the School of Chemical Sciences in this University.
