GCCEM/Admn./MNM-PF/2021-22/436 in order to report to Goa University.

Now therefore, Ms. Norma Menezes, Associate Professor is hereby posted in the discipline of Philosophy in the School of Philosophy, Sanskrit and Indic the district with effect from 24/09/2021 (B.N.). Her basic pay will be fixed at Rs. 131400/- as per rules in the Academic Level 13A, Rs.131400 - Rs.217100. She is entitled to other admissible allowances as per rules.
