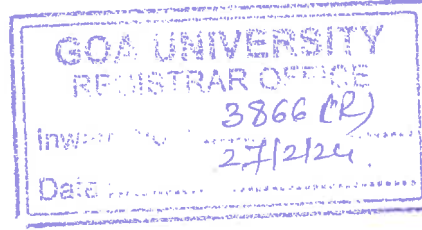


### APPOINTMENT ORDER
