ORDER

Subject: Financial approval for the award Research Scientist Scheme fellowship to **Dr. Sohini Ganguly** to be implemented at **Goa University, Taleigao. Goa-403206.**

The sanction of the SERB is hereby accorded to the above mentioned project at a total cost **Rs.46,00,000/-** (Rs. Forty Six Lakhs Only) for a period of two years with a break up of **Rs.30,00,000/-** as Fellowship amount and **Rs.14,00,000/-** Under Research Grant Head and **Rs.2,00,000/-** under the Overhead. The items of expenditure for which the total allocation of **Rs.46,00,000/-** has been approved for a period of two years are given below:

2. The sanction of the SERB is also hereby accorded to the payment of **Rs. 23,00,000/-** in total (**Rs.15,00,000/-** Under Fellowship amount **Rs.7,00,000/-** under Research Grant and **Rs.1,00,000/-** Under Overhead charges) assets to **Goa University, Taleigao. Goa-403206** being the first instalment of the grant for the year 2019-20 for implementation of the above said project.

3. The expenditure involved is debitable to **Fund for Science & Engineering Research (FSER)**. This release is being made under **SERB Research Scientist Scheme**.

4. The Sanction has been issued under the powers delegated to the Science and Engineering Research Board and with the concurrence of the competent authority under delegated powers vide Diary No. **SERB/F/2153/ 2020-21** dated **07.08.2020**.

5. Overhead expenses are meant for the host Institute towards the cost for providing infrastructural facilities and general administrative support etc.

6. SRS is a purely temporary assignment. There is no provision for providing manpower support under this scheme. The Research Scientist is expected to undertake the research objectives by himself/herself during the entire duration of the SRS. Sanction of the grant is subject to the terms and conditions as detailed in the website (www.serb.gov.in).

7. As per rule 211 of GFR the accounts of Grantee Institution shall be open to inspection by the sanctioning authority / audit whenever the institute is called upon to do so.

8. The release amount of **Rs.23,00,000/-** will be drawn by the Under Secretary of the SERB and will be disbursed by means of RTGS transaction as per their Bank details given below:

9. The institute will furnish to the SERB, Utilization certificate(UCs) and an audited statement of accounts pertaining to the grant immediately after the end of each financial year.


10. The institute will maintain separate audited accounts for the project. A part or whole of the grant must be kept in an interest earning bank account which is to be reported to SERB. The interest thus earned will be treated as credit to the institute to be adjusted towards further installment of the grant.

11. As this is the first grant being release for the project, no previous UC is required.

12. After completion of the project unspent balance if any should be returned as Demand Draft drawn in favour of "Fund for Science and Engineering Research" payable at New Delhi.

13. The organization / institute / university should ensure that the technical support/ financial assistance provided to them by the Science & Engineering research Board, a statutory body of the Department of Science and Technology (DST), Government of India should invariable be highlighted / acknowledge in their media releases as well as in bold letters in the opening paragraphs of their Annual Report.

14. In addition the investigator/host institute must also acknowledge the support provided to them in all publications patents and any other output emanating out of the project/ program funded by the Scinece and Engineering research Board, a statutory body of the Deoartment of Science & Technology (DST) Government of India.
