With reference to your Walk-in-Interview held on 25th June, 2012, I am directed to inform you that on the basis of recommendation of the Selection Committee, the Hon'ble Vice Chancellor, as per the provision under Statute 18(6)(ii) of the Central Universities Act, 2009 is pleased to appoint you as **Assistant Professor in Public Policy, Law and Governance** in the **School of Social Sciences** on purely temporary basis for a period not exceeding one year or till the regular appointments are made, whichever is earlier, on the following terms and conditions.

TERMS AND CONDITIONS:

1. You will be entitled for a salary at the minimum of the pay in the Pay Band Rs. 15,600-39,100 + AGP 6,000/- plus allowances admissible as per the UGC and government norms.
2. Your services will be governed by the provisions of the Central Universities Act 2009 and the Statutes including Manuals, Ordinances, Regulations and Rules of the University in force and may be made from time to time.
3. Your appointment is subject to verification of all the relevant documents and certificates.
4. Your appointment will not vest any right to claim for regular appointment in the University or for continued contractual appointment.
5. If any declaration/information furnished is found false or if any material/fact is found suppressed, the appointment will be terminated forthwith.
6. This appointment is purely on temporary basis and it can be terminated anytime by the University during the period of the contract without assigning any reason or giving any notice.
7. The employee shall have to give one month notice or deposit an amount equal to one month remuneration if he/she wishes to terminate the contract.


