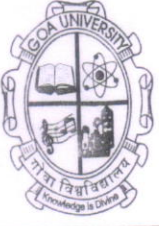



As a teacher in the School, Dr. Kajal Rivankar contributed in the organizing of the following activities:

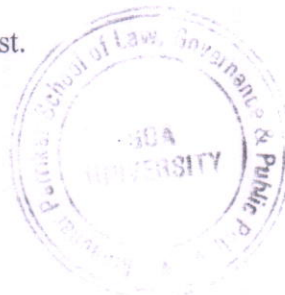

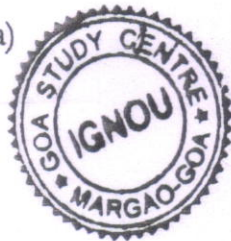



The foundation laid by the team helped the development of the Manthan- Pilot project into a full-fledged long-term project.
