The Fellowship amount shall be disbursed through Canara Bank to the bank account of the awardee (any bank) directly. The Universities/Institutions will submit your update master data on the dedicated web-portal (<https://scholarship.canarabank.in>). The amount of fellowship and contingency is as under:-

Fellowship (I, II, & III year) : ₹50,000/- p.m.  
Contingency : ₹5,00,000/- p.a.

It is informed, Aadhaar may be used as an identifier for disbursement of all Government subsidies/Scholarships/Fellowships, which are to be disbursed directly into the beneficiary's account in accordance with the instructions issued by the Government of India. The Universities / Institutions may terminate fellowship of any awardee in any of the following cases, under intimation to UGC:

- If the awardee is found to be ineligible to receive the award, at any point of time during the entire duration of the fellowship.
- Misconduct of awardee.
- Unsatisfactory progress of research work of the awardee.
- If, any other fellowship drawn from other source(s).
- Concealment of facts and on any other ground of misconduct.
