With reference to your application for ICCR Scholarship 2019-20, I am please to inform you that you have been selected for admission at Goa University, Goa. In this connection, please note the following;

1. You are advised to report to Assistant Registrar (PG)a, University of Goa at the earliest long with all original certificate and testimonials/mark sheets and transcript copies of the same to be produced at the time of admission failing which admission will be canceled.

No extension in joining time will be given under any circumstances. If you fail to report by this date the provisional admission will be treated as canceled by the university. Journey arrangements may be conveyed to the Embassy to ensure reception at the Airport on arrival.

2. Please get well acquainted about the course of study and the Educational Institution before proceeding to India.

3. No request for change of course and/or university/institute will be entertained. Hostel accommodation is not guaranteed and may be provided subject to its availability.

4. Government of India will bear the expenses on account of living allowance, tuition fee payable to university and hostel accommodation as per the ICCR Scholarship Scheme. However, the cost of travel from Ulaanbaatar to the place of study and vice-verse has to be borne by you.

Scholars pursuing science course are required to bear the cost towards chemicals and other incidental charges.

6. You are advised to carry sufficient money (a minimum of Rs. 50,000.00 equivalent to US\$ 750-800 is recommended) to meet any incidental/miscellaneous expenditure after your arrival in India.

7. In case you abandon the studies anytime while pursuing the course, you will refund the entire money paid by the government of India or spent on you.

8. Please note there is requirement to register with the local FRO/FRRO with 14 days of your arrival in India.

9. It is also informed that you are entitled scholarship is due only up to declaration of final result.
