## ORDER

**Read Order: DAC/Accts/Res-chair/Goa University/2011-12/3171 dated 28/09/2011 and subsequent amendment to the scheme dated 20/07/2015**

Administrative approval and Expenditure sanction of the Government is hereby accorded for release of recurring grant-in-aid of Rs.15,00,000/- (Rupees fifteen lakhs only) to Goa University for establishing research chairs in the name of Kavivarya Bakibab alias Shri. B B. Borkar Chair for Comparative Literature in the Department of Konkani under the scheme for Establishing Research Chair at Goa University and Renowned Institutions - 2011 for the financial year 2018-19.

1. The amount shall be released in the form of Gran-in-Aid.
2. Goa University shall incur the administrative expenditure to establish Chair in the name of Kavivarya Bakibab alias Shri. B B. Borkar.
3. Shall educate and train specialists in the chosen filed on the chair.
4. Shall appoint a Doctoral fellowship to deserving candidate who will work under the guidance of the chair professor to carry out this research work.
5. Shall design and develop innovative techniques in the field of the subject of the chair.
6. Shall establish effective multidisciplinary designs, teams and networks.
7. Shall undertake research programmes relevant to the chosen subject.
8. Shall incorporate elements of selected subject of the chair in the post-graduate courses in various disciplines.
9. Shall interact with academics and research institutions in India and abroad, involved in the chosen subject of the chair.
10. Shall organize and facilities holding of, seminars, symposia, conference, lectures, study circles, summer schools, correspondence courses, etc. and to undertake such other academic activities as contributing to a deeper understanding of the different branches of the connected with subject of the chair.
11. Shall start an active publication programme and bring out on a regular basis books, translations and occasional papers.
12. Shall initiate research in the educational field in order to widen the horizon so as to make it an effective instrument for social changes and national development.
13. The grant -in-aid shall be disbursed in one instalment.
14. The grantee institution shall follow all the financial rules and procedures as laid down by the Government from time to time.
15. The grantee Institution shall submit the audited statement of accounts as well as the utilization certificate in form GFR 19-A, of the expenditure incurred out of the grants duly certified by the chartered accountant within six months from the close of the financial year 2018-2019.
16. The grant shall be strictly utilized purely for the purpose for which it is granted. The amount so granted shall be liable to be recovered if it is used for the purpose other than as referred above.



17. The Assets acquired wholly, substantially or partially out of this Government grant except those declared as obsolete and unserviceable or condemned with prior approval of the Government in accordance with the procedure laid down in General Financial Rules shall not be disposed off or encumbered or utilized for purpose other than those for which the grant was given without prior sanction of Government. Further, the assets so acquired shall revert to Govt. in case of winding up of grantee institution. The inventory of assets/articles shall be maintained in appropriate forms as prescribed under General Financial Rules.
  18. No grant shall be allowed to be paid to any other institutions/voluntary organizations out of this special onetime grant sanctioned by the Government.
  19. The activities conducted under the Chair shall be evaluated by the Goa College of Architecture and a detailed quarterly report in this regards shall be submitted to the Government through the Directorate of Technical Education.
  20. The grantee institution must exercise reasonable economy and observe all financial property as issued by the Government from time to time while incurring the said expenditure.
  21. In case of mis-utilisation of grants, the amount so mis-utilised shall be recovered from the grantee institution with 5% penal interest.
  22. The amount remaining unspent out of this special grant shall be refunded back to the Government treasury by way of challan within 3 months from the close of the financial year 2017-18.
  23. The amount shall be draw, from the Directorate of Accounts on presentation of the bill in form GAR - 32 duly counter signed by the Drawing and Disbursing Officer, Directorate of Art & Culture.

The expenditure shall be debited to the budget head of Account 2205- Art & Culture, 00, 102-Promotion of Art & Culture, 63- Establishment of various chairs at Goa University (P), 31- Grant-in-Aid under the Demand No.43.

The scheme for establishing Research Chair at Goa University -2011 and the Pattern of Assistance governing the grant-in-aid for establishing the chair is approved and concurred by the Finance (Exp) Department vide its U.O No. 1435845 dated 24/03/2011 and subsequent amendment to the scheme concurred vide U.O. 1858/F dated 9/7/2015.

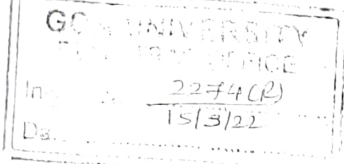

### ORDER

Administrative approval and Expenditure sanction of the Government is hereby accorded for release of recurring grant-in-aid of Rs.35,00,000/- (Rupees Thirty Five Lakhs only) to Goa University as per the enclosed Annexure for establishing research chairs under the scheme for Establishing Research Chair at Goa University and Renowned institutions- 2011 for the financial year 2022-23.

1. The amount shall be released in the form of Grant-in-Aid.
2. The grantee institution shall follow the rules and regulations as per the Pattern of Assistance of the Scheme.
3. The grantee institution shall follow all the financial rules and procedures as laid down by the Government from time to time.
4. The grantee Institution shall submit the audited statement of accounts as well as the utilization certificate in form GFR-12-A, of the expenditure incurred out of these grants duly certified by the Chartered accountant within three months of the close of the financial year 2022-23.
5. The grantee Institution shall submit the rectified audited statement as well as the rectified utilization certificates of the expenditure incurred out of the grants received since financial year 2011-12, duly certified by the Chartered accountant, within three months of the receipt of these Grants.
6. The grant shall be strictly utilized purely for the purpose for which it is granted. The amount so granted shall be liable to be recovered if it is used for the purpose other than as referred above.
7.
