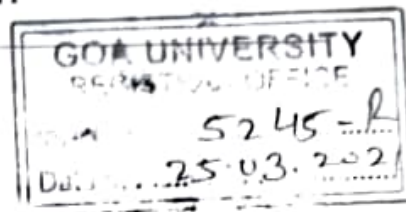

1. While selecting a visiting professor for the V.M. Salgaocar Chair as well as during selection of the Post- Doctoral Fellow, a representative of the V.M. Salgaocar Trust (V.M.S Trust) shall be present on the selection Committee;
2. VMS Trust shall indicate to Goa University (GU) its preferred choices of research areas in wild life studies conservation and habitat management;
3. V.M. Salgaocar Post-Doctoral Research Fellow shall undertake research in wildlife, training the students in wildlife, flora and fauna, conservation and habitat management, conduct workshops, teach and publish papers in peer reviewed reputed science journals;
4. The funds released shall be utilised to meet running expenses of the Chair and Post-Doctoral Research Fellow;
5. Funds released shall not be utilised for capital expenditure;

6. At the end of the year, a joint review of the activities undertaken shall be conducted and the GU shall submit a report to the V.M.S Trust;
7. The GU shall submit utilisation certificate at the end of the year as required under the regulations governing the Corporate Social Responsibility (CSR) activities conducted by V.M.S Trust.

You are hereby requested to utilize the funds in accordance with the aforesaid terms and conditions and the MOU dated 23rd February 2021, executed between Goa University and V.M.S Trust.
