The objective	The objective of the event was 1) To help students understand the scope social work interventions that are possible with the help of law and the criminal justice system. 2) It was intended to help the students gain insight into practical difficulties in implementing the law. 3) Interact and develop networks with people working in the social work profession.
Description of the activity	In his presentation, Arun Pandey Arz had worked at three levels to protect the victim of sex trafficking:

	I-Drafting New Laws / New Legal Provisions Definition of Human Trafficking and provision banning dedication of girls as devadasi. II- Interpretation of provisions in the interest of combating Sex Trafficking. III-Enabling in proper implementation of laws: Rescue, Medical, - Services at Protective home, Repatriation, - Reintegration He spoke of the PILs filed on Baina Demolition and improving the conditions of Protective Home.
Benefit/Key outcome of the event	The students through his lecture were able to understand practical and field level interventions that are possible through the law in social work settings. They also understood the difficulties encountered in working with the system and the need for sustained advocacy to achieve change.
