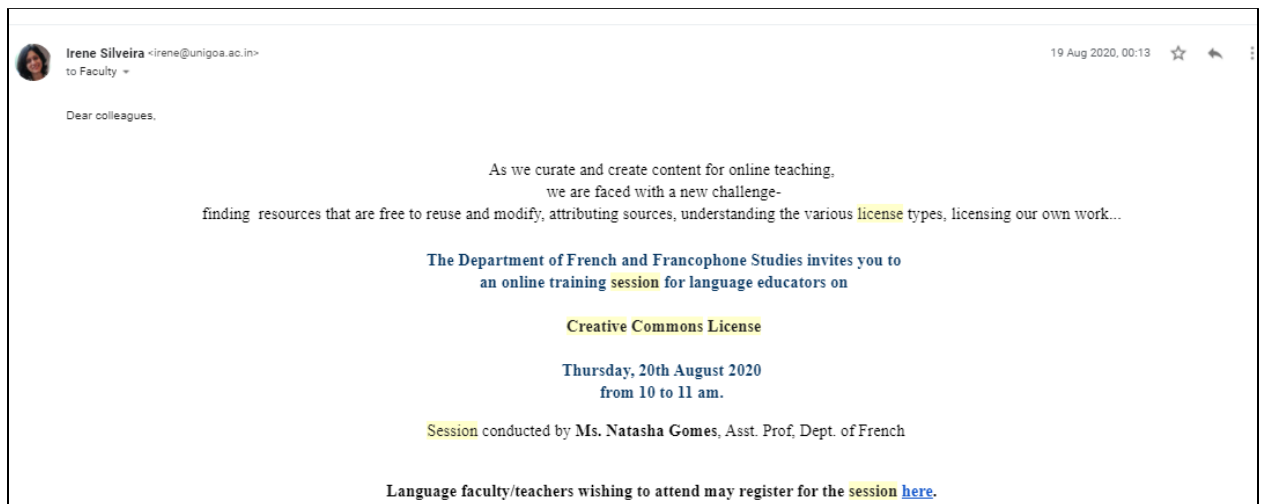


1. Title of the event: Creative Commons Licenses
