Preliminary Investigation into the Archival Sources Relating to Indo-Oman Trade
Relationship in the Pre Modern Period in the Goa Archives

Since the ancient period, India has maintained close relationship with West Asia including Persia and Oman. Western coastal India comprises several ports distributed in the modern states of Gujarat, Maharashtra, Goa, Karnataka and Kerala. Among these, the ports such as Chaul, Dabhol, Goa, Karwar, Bhatkal, Mangalore, Calicut and Cochin have played an important role in maintaining the trade relationship in the pre-Islamic and Islamic periods. The Arab travelers who came to western India discussed the ports and shipping in the territory controlled by the Rashtrakutas. This detail pertain to the ancient period. We have the rich information regarding this trade relationship under the Goa Kadambas when the Muslim traders visited Goa to supply horses and purchase rice and other food items back home. In the South, Mangalore emerged as an important port. There was a Mangalore-Aden trade relationship as discussed in the famous Geniza documents. In the medieval period, Ibn Batuta visited western coastal India and he has given descriptions concerning the trade that existed in the ports such as Honnavar and Mangalore. Before the Portuguese, Goa was ruled by the Bahamanis, the kingdom of Deccan. The Portuguese were able to capture this port from the Muslims. However, the Indo-Oman relationship did not decline. Muscat emerged as an important port with which the Portuguese maintained trade relationship. Coming of the English to India in the seventeenth century further complicated the relationship between Oman and the European powers, which established their settlements in different parts of India. There are sources that discuss the trade relationship between Muscat, Mangalore, Karwar and Goa. Even in the seventeenth century, the local kings of Karnataka sought permission from the Portuguese to sail to Muscat, thereby showing that India and Oman trade did not decline despite the hostile approach of the Portuguese. In the Portuguese period, we have large numbers of archival documents relating to this trade. From Muscat, Indians imported horses while from India, there was the export of rice, pepper, cardamom

and other articles.

With reference to the Indo-Oman relationship, it is important to locate the Portuguese sources, which are available in the Goa Archives, transliterate and translate them. For example, we have the volumes of *Moncoes do Reino* and *Alvaras* which have considerable information regarding the economic and cultural relationship between India and Oman. At the end of this proposal I have placed a list of sources, which will act as a guide to pursue this research.

The present project is an attempt in this direction. Goa possesses the sufficient human power to achieve this task. The Department of History and the Department of Portuguese of Goa University and the Directorate of Archives and Archaeology of Goa have decided to collaborate in locating the sources in accordance with the discussion held in the month of June, 2019 with delegation of the National Records and Archives Authority (NRAA), Sultanate of Oman, headed by His Excellency Director General of Records Organization Abdulmohsin Said Al-Hinai and Dr.Hamed Mohd. Al Dhawiani, Chairman of NRAA.

The budget estimate for this project is enclosed herewith. The project is also the outcome of the suggestion of the Esteemed Vice Chancellor of Goa University Prof. Varun Sahani that there is a need for a collaboration between Goa University, Goa Archives and NRAA.

### Significance

This project is significant because for the first time an attempt has been made to locate and translate the Portuguese original sources related to the Indo-Oman relationship. The research scholars and the public belonging to India and Oman are likely to benefit from this study. Authorities of Goa Archives have assured of the possible help in this regard.

### Methodology

This study will attempt to study the Portuguese sources in the Goa Archives pertaining to Indo-Oman trade relationship. The study is purely empirical with the larger aim of creating a database that can be used by the researchers to use these sources in their research.

### **Project Outcome**

The project should result in collecting and disseminating information concerning the Indo-Oman trade relationship by scanning the documents, translating and uploading them on the website that would be constructed for this purpose. It is also planned to bring out a publication of this work at a later date.

### Modalities

Dr. Nagendra Rao, Professor in Department of History will be the Principal Investigator of the project. The official documents related to the income and expenditure of the project would be routed through Goa University. The funding agency needs to send the estimated amount and administrative charges to the **Registrar**, **Goa University**. This is the first phase of this research. In the next phase, more intensive research will be undertaken. Time frame for this project is 12 months.
