- The original terms and conditions governing the financial sanction will remain unchanged.
- ii. As per Rule 236 (1) of GFR 2017, the accounts of all Grantee Institutions or Universities shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department whenever the Institution or Organization is called upon to do so.
- iii. The Indian host institute should ensure attendance, progress evaluation before disbursement of fellowship to the fellow. The University/Institute Head are requested to furnish Progress/Final Report along with the Utilization Certificate and an audited Statement of Expenditure at the end of financial year to this Department/RCB. The statement and requirement should be sent within 2 weeks of completion of the disbursement period.
- iv. The Institute/Agency will keep the whole of the grant in a Separate Bank Account earning interest, and the interest so earned should be reported to DBT in the Utilization Certificate and Statement of Expenditure. As per the provision contained in Rule 230(8) of GFR 2017, all interests/other occurred against Grants-in-aid shall be mandatory remitted to the consolidated fund of India through the online portal <a href="https://www.bharatkosh.gov.in">www.bharatkosh.gov.in</a>.
