#### CIRCULAR

Applications are invited from eligible Under-Graduate, Post-Graduate, Post-Graduate Diploma Students enrolled in various Schools of the University Campus for the Award of Merit Scholarship, Free Studentship and Student Aid Fund for the academic year 2024-25.

The eligibility criteria for Merit Scholarship, Free Studentship and Student Aid Fund are as under:

#### **MERIT SCHOLARSHIP**

1. Candidate at qualifying examination should have secured at least 65% of aggregate marks.

#### FREE STUDENTSHIP

- 1. The applicant should belong to an income group not exceeding ₹. 3,00,000/-per annum for the Financial Year 2023-24.
- 2. The candidate should have secured at least 45% of aggregate marks at the last qualifying examination with no backlog.
- 3. Applicant should be a resident of Goa for 15 years.

#### STUDENT AID FUND

- 1. The applicant should belong to an income group not exceeding ₹.1,50,000/-per annum for the Financial Year 2023-24.
- 2. The candidate should not have any backlog in his/her qualifying examination.
- 3. Applicant should be a resident of Goa for 15 years.

The students shall compulsorily submit the necessary documents along with their form for various scholarships as follows:

#### MERIT SCHOLARSHIP

a. Self-attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year 2023-24. In case the programmes having only 1 semester may submit the self-attested mark sheet of semester I for the Academic year 2023-24.

- b. A clear copy of the first page of the applicant's Bank passbook/ Cancelled Cheque/ Bank Mandate form which is duly signed by the Bank Official.
- c. A clear copy of the fee receipt.

#### FREE STUDENTSHIP

- a. Self-attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year 2023-24. In case the programmes having only 1 semester may submit the self-attested mark sheet of semester I for the Academic year 2023-24.
- b. Family income Certificate of the Financial Year i.e. **2023-24** which should be less than or equal to ₹.3,00,000/- (only family income certificate will be considered and **not** the individual income certificate).
- c. A clear copy of the first page of the applicant's Bank passbook/Cancelled Cheque/Bank Mandate form which is duly signed by the Bank Official.
- d. A clear copy of the Ration Card.
- e. A clear copy of the Residence Certificate.
- f. A clear copy of the fee receipt.

#### STUDENT AID FUND

- a. Self-attested mark sheet copies of both semesters (odd & even) of qualifying examination for the Academic Year **2023-24**. In case the programmes having only 1 semester may submit the self-attested mark sheet of semester I for the Academic year **2023-24**.
- b. Family income Certificate of the Financial Year i.e. **2023-24** which should be less than or equal to Rs. 1,50,000/- (only the family income certificate will be considered and **not** the individual income certificate).
- c. A clear copy of the applicant's Bank passbook/ Cancelled Cheque/Bank Mandate form, duly signed by the Bank Official.
- d. A clear copy of the Ration Card.
- e. A clear copy of the Residence Certificate.
- f. A clear copy of the fee receipt.

If the marks of the student are not stated on the mark sheets submitted by the student for the Academic Year 2023-24, then the School is requested to submit the Marks equivalent Certificate.

Students who are working professionals are not eligible to apply for the Merit Scholarship/ Free Studentship/ Student Aid Fund.

Those students availing the benefits under any other Schemes/ Scholarships shall not be eligible to avail similar benefits under the Goa University Scholarships. The students would however be permitted to exercise their choice of Schemes/ Scholarships to avail similar benefits.

Students are free to apply for Merit Scholarship, Free Studentship & Student Aid Fund, but shall be eligible for the award of only one Scholarship.

Candidates should note that documents such as Bank details, Mark sheets, Income Certificate, Residence Certificate, Fee Receipt and Ration Card should be valid, else the application is liable to be rejected.

All the students desirous of applying for the Merit Scholarship, Free Studentship and Student Aid Fund are requested to fill out the requisite form which is available in the Schools and submit the duly filled-in form, complete in all respects with necessary documents, to the concerned School/Discipline. A single form should be used even if the student is applying for more than one scholarship.

The last date for students to submit applications to their respective Schools is 10/01/2025

The Programme Directors of the Discipline of Schools are requested to verify the application forms (Format attached as Annexure I) and forward the same to the Dean for final approval. The duly signed Application forms by the Deans, along with the hard copy of the application summary (Format attached as Annexure II) has to be submitted to the Directorate Office and soft copy to dtt.office@unigoa.ac.in by 24/01/2025.
