CIRCULAR

Applications [Online] are invited from eligible Under Graduate, Post Graduate, Post Graduate Diploma students enrolled in various Departments of the University for Award of Merit Scholarship, Free Studentship and Student Aid Fund for the academic year 2019-20.

The eligibility criteria for Merit Scholarship, Free Studentship and Student Aid Fund are as under:

MERIT SCHOLARSHIP

1. Candidate at the qualifying examination should have secured at least 60% of aggregate marks in respect of Arts, Commerce & Management Studies and at least 65% of the aggregate marks in Science Stream.

FREE STUDENTSHIP

1. The applicant should belong to the income group not exceeding Rs. 3,00,000/- per annum for the financial year 2018-2019.
2. The candidate should have secured at least 45% of aggregate marks in Arts, Commerce & Management Studies and 50% of the aggregate marks in Science subjects at the last qualifying examination.
3. The beneficiary of any Other Government Scholarship/ Student Aid Fund of Goa University is however not entitled for a Free Studentship award.

STUDENT AID FUND

1. The applicant should belong to the income group not exceeding Rs. 1,50,000/- per annum for the financial year 2018-19.
2. The beneficiary of any other Government Scholarship/ Free Studentship of Goa University is however not entitled for a Student Aid Fund award.

Candidates should note that the Merit Scholarship/ Free Studentship/ Student Aid Fund will be rejected if it is found from the records that they do not fulfill the conditions of at least 75% attendance at the lectures and practicals, wherever prescribed and uploading invalid documents.

All the students desirous of applying for the Merit Scholarship, Free Studentship and Student Aid Fund are requested to fill the requisite form on the GUMS Portal with their login ID given after Registration and submit the same duly filled in and completed in all aspects. The students are also requested to upload compulsorily necessary documents for various scholarships which are as follows:

1. Merit Scholarship

- (a) Scanned copy of qualifying examination marksheet (previous year marksheet)
- (a) Mandate Form duly signed by the Bank//photocopy of Bank Passbook/cancelled cheque.

2. Free Studentship

- (b) Scanned copy of qualifying examination marksheet (previous year marksheet).
- (c) Income Certificate of the parents of last financial year i.e. 2018-2019.
- (d) Mandate form duly signed by the Bank//photocopy of Bank Passbook/cancelled cheque.


3. Student Aid Fund

- (a) Income Certificate of the parents of last financial year i.e. 2018-2019.
- (b) Mandate form duly signed by the Bank//photocopy of Bank Passbook/cancelled cheque.

Students are free to apply for all three scholarships however shall be awarded a maximum of two scholarships.

The last date for students to apply online on the GUMS Portal is **8th November 2019.**

All the Deans of School/ Heads of the Departments are requested to verify the forms on the GUMS Portal and forward the same online on or before **18th November 2019.**
