OFFER OF APPOINTMENT CUM POSTING ORDER

On recommendation of the Department Selection Committee and on approval of the Secretary (Health)/ Mission Director (NHM), Ms. Sona Gaonkar, is selected for the post of State Entomologist (BPHU) and posted at District Surveillance Unit, Asilo Hospital Mapusa and Deployed to Block Public Health Units - North purely on contract basis under NHM by the State Health Society, Directorate of Health Services, Panaji, for the period from the date of joining the post to 29th June 2025, on a monthly consolidated emolument of ₹ 40,000/- (Rupees Forty Thousand only).

The Appointment shall be governed by the Terms and Conditions contained in the Agreement to be executed by candidate with the State Health Society, Directorate of Health Services, Panaji Goa.

This offer of appointment is subject to the following conditions:

- 1. Candidate could be posted at different parts of the state.
- 2. Since he/she is appointed under National Health Mission (NHM), he/she shall have no claim for absorption in State Govt. Service.
- 3. Candidate should join the place of posting within 10 days, failing which it will be presumed that he/she is not willing to join the post.
- 4. He/She should produce a Medical fitness certificate issued by the Medical Supdt./Dy. Director, North District Hospital, Mapusa/ Hospicio Hospital, Margao.

NOTE:

- 1. He/She should submit their willingness in writing along with a Medical Fitness Certificate <u>within</u> <u>10 days</u> of receipt of the offer letter to this office, failing which it will be presumed that he/she is not willing to join the post.
- 2. He/She should report to this office with Fifty Rupees Stamp paper to sign the agreement **before joining the post**.
