They will not be entitled to any other allowances. Their appointment subject to the term and conditions are as below:-

That in consideration of the payment to be made by the Government to the
official in the manner hereinafter mentioned, the official shall serve as Sagar
Mitra to the Directorate of Fisheries, Government of Goa,

- 2 The appointment of the Official on contract basis as aforesaid shall not bestow on the official any right or claim to be appointed in the regular service of the Government.
- That the official shall submit himself to the orders of the Government, or such Officer, under whom he she may be placed by the Government and shall at all times obey the rules and regulation for the time being in force and shall carry out the duries as assigned to him/her from time to time during the contract period.
- 4. That the official shall employ himself therself efficiently, diligently and to the best of his abilities to the duties assigned to him and shall not engage, directly or indirectly, in any trade or business on his own account. Further, the Official shall not (except in case of accident or sickness certified by competent authority) absent himself from his duties without prior permission from the Director of Fisheries, Panaji.
- That the Government may terminate this Agreement at any time by giving one calendar month notice in writing, if the official is found guilty of any breach of rules governing the persons in public service or for breach of any of the terms and conditions berein specified.
- one month advance notice in writing and on expiry of such notice, this agreement shall stand terminated. In the absence of such notice to the Government, the official shall refund to the Government an amount equivalent to the pay of one month in lieu of the said notice.
- 7. That the Government shall pay to the official so long as he shall remain in office and actually perform his duties as Sagar Mitra, a performance incentive of Rs. 10000/-per month against a set of predetermined tasks. Further, additional performance incentives up to Rs 5000/- in a month may be given to Sagar Mitra against transport charges, mobile phone top up charges and other additional tasks entrusted from time- to-time.
- 8. The official shall not be entitled to any allowances such as D.A., H.R.A., C.C.A., etc.
- Whenever the official is required to go out of the Headquarters on official duties, he shall be entitled to draw TA/DA as admissible to Official of corresponding grade as per his pay.
- 10. That the official shall not be entitled to the benefit of General/Contributory Provident Fund (GPF/CPF).
- 11. That the Official shall be entitled to Casual Leave & sick leave as per O.M. No. 10/1/77-PER(Part)/3282 dated 20-06-2022. However, encashment of leave shall not be permissible. The Official shall not be entitled to any other kind of leave.
- 12. The Official shall not be entitled to reimbursement of medical expenses as applicable to Government Official of corresponding status under the Medical Attendance Rules.

13. In the event of any question, dispute or difference arising under or out of or in connection with the condition herein contained or touching or concerning the meaning or operation of and as to rights, liabilities of the parties hereto, the same shall be referred to the sole arbitration of a person appointed by the Director of Fisheries to the Government of Goa. There shall be no objection to any such appointment on the ground that the arbitrator so appointed is a Government employee and that he has expressed his view in all or any of the matter in dispute or difference. The award of the arbitrator so appointed shall be final and binding on the parties to these presents. Save as aforesaid, the provisions of the Arbitration and Conciliation Act, 1996 and the rules framed there under, shall apply to the arbitration proceedings under the clause

The appointment is effective from the date they join the duties.
