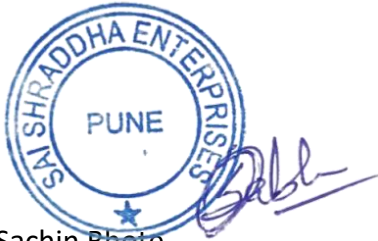
Following are other terms and conditions related to your appointment.
