[Note: Candidates possessing M.Phil. or equivalent degree, of this University or of any other recognized University are exempted from the two Courses; however, they shall be required to give a Seminar, as in the case of other students.]

Your registration of the Ph. D. programme shall be confirmed from the date of provisional registration, only if you qualify in the Course Work at the Seminar Presentation of the work done.

You are required to pay your fees annually before/by the date of initial registration of Ph.D. to continue to be registered with the Programme.
