During the training period and there after you will not pass on to any one in writing or by word of mouth or otherwise, particulars or details of work, process, technical know-how, research carried out, administrative and/or organizational matters of confidential nature which you may come across during your training period or become known to you by virtue of your undergoing training in the company or otherwise.

6. POSTING

During your training period you may to be transferred or assigned to work in any division, department, establishment or location at which the company or its associate's companies have their offices or operation and whether at present existing or which may be set up in future at any time and at any place in India without any increase in stipend.

7. TRAINING, HOURS LEAVE AND HOLIDAYS

In the event of you remaining absent without leave or permission for consecutive 7 days or more and/or over staying sanctioned leave beyond 7 days, you are liable to be treated as having abandoned the training and will loose your lien on training.

10. AFTER COMPLETION/TERMINATION OF TRAINING

On completion/termination of training you will immediately surrender to the company all specification, documents, literature, drawings, records etc. belonging to the company or relating to its business and shall not take or retain any copies of the said items.
