During the first year of Registration you are required to undertake the following activities:

- Finalize the proposal of the research work in consultation with the Research Guide/s within six months from the date of provisional registration.
- Successfully undergo two theory courses namely, one in Research Methodology and the other in Advanced Theory related to the proposed research work in the chosen field of research.
- Submit a Progress Report of the first year and make a Seminar of the work done on the basis of the objectives of the proposal with justification for the selection of the proposed topic/area of research, before the DRC and other interested faculty members/research scholars/students at the end of the first year.

Note: Candidates possessing M.Phil. through regular mode or equivalent degree, of this University or of any other recognized University are exempted from the two Courses; however, they shall be required to give a Seminar, as in the case of other students.

Your registration of the Ph. D. programme shall be confirmed from the date of provisional registration, only if you qualify in the Course Work at the Seminar Presentation of the work done.

You are required to pay your fees annually before/by the date of initial registration of Ph.D. to continue to be registered with the Programme.
