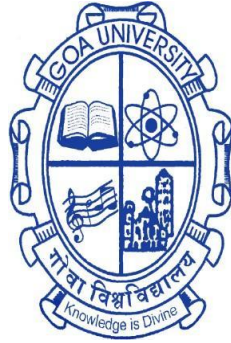

9. A Registrar of Assets acquires wholly or subsequently out of the grant shall be maintained by the University in the prescribed Form.

In case of non-utilization/part utilization thereof, simple interest @ 10% per annum, as amended from time to time on the unutilized amount from the date of drawl to the date of refund as per provisions contained in General Financial Rules of Govt. of India, will be charged.

### ORDER

1. The amount shall be released in the form of Grant-in-Aid.
2. The grantee institution shall follow the rules and regulations as per the Pattern of Assistance of the Scheme.
3. The grantee institution shall follow all the financial rules and procedures as laid down by the Government from time to time.
4. The grantee Institution shall submit the audited statement of accounts as well as the utilization certificate in form GFR-12-A, of the expenditure incurred out of these grants duly certified by the Chartered accountant within three months of the close of the financial year 2022-23.
5. The grantee Institution shall submit the rectified audited statement as well as the rectified utilization certificates of the expenditure incurred out of the grants received since financial year 2011-12, duly certified by the Chartered accountant, within three months of the receipt of these Grants.
6. The grant shall be strictly utilized purely for the purpose for which it is granted. The amount so granted shall be liable to be recovered if it is used for the purpose other than as referred above.
7. The Assets acquired wholly, substantially or partially out of this Government grant except those declared as obsolete and unserviceable or condemned with prior approval of the Government in accordance with the procedure laid down in General Financial Rules shall not be disposed off or encumbered or utilized for purpose other than those for which the grant was given without prior sanction of Government. Further, the assets so acquired shall revert to Govt. in case of winding up of grantee institution. The inventory of assets/articles shall be maintained in appropriate forms as prescribed under General Financial Rules.
8. No grant shall be allowed to be paid to any other institutions/voluntary organizations out of this grant sanctioned by the Government.
9. The grantee institution must exercise reasonable economy and observe all financial property as issued by the Government from time to time while incurring the said expenditure.
10. In case of mis-utilisation of grants, the amount so mis-utilised shall be recovered from the grantee institution with 5% penal interest.
11. The amount remaining unspent out of this grant shall be refunded back to the Government treasury by way of challan within 3 months from the close of the financial year 2022-23.
12. The amount shall be draw, from the Directorate of Accounts on presentation of the bill in form GAR - 32 duly counter signed by the Drawing and Disbursing Officer, Directorate of Art & Culture.

Further, Goa University requested this Department to release funds of Rs.40,37,271/- to organise the activities of the Chairs for the financial year 2023-2024.

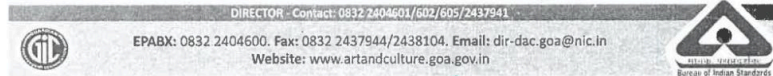
