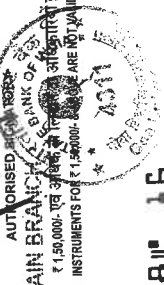

- The main objective of the Foundation is to promote communal harmony and national integration through variety of schemes and activities; and provide financial support for effective rehabilitation of child victims of communal, caste, ethnic or terrorist violence and their care and education under Project 'Assist'. The Foundation has been collaborating with Central/State Governments, District Administrations, reputed academic institutions, civil/ voluntary organizations and other likeminded organizations to conduct variety of programmes including seminars, symposiums, cultural events, interfaith dialogue, literary competitions and other similar significant initiatives to achieve its mandate.
- The NFCH had received a modest corpus from the Government of India in 1992. The Foundation does not receive any regular grant/financial support from the Government. The interest earned thereon is not adequate to carry forward our expanding activities. However, the Memorandum of Association (MoA) of the Foundation allows for collection of donations from different sources for supporting destitute children and for carrying out its activities.

Steps for observance of 'Communal Harmony Campaign Week and Flag Day 2023'

The following steps are required to be taken for observance of the Communal Harmony Campaign Week & Flag Day 2023:

- (i) To do campaigning and provide wide publicity for sensitizing officers, staff and public as a whole about the need for fostering communal harmony, National Integration and fraternity. Keeping in view the outreach, effective use may be made of social media, seminars, competitions and other activities etc.
- (ii) To make arrangements for circulation of fund collection boxes – wooden, plastic or metallic boxes may be improvised with suitable openings to insert the donation.
- (iii) To select volunteers from amongst students and staff to station themselves at the entrance and other vantage points and go around the office buildings on the Flag Day for distribution of flag stickers and collection of voluntary donation.
- (iv) To make suitable arrangements for proper security of collection boxes, opening them, counting the amount so collected and sending to NFCH.
- (v) Remittance of funds so collected should be made through Demand Drafts/cheque in favour of '**Secretary, National Foundation for Communal Harmony**' and sent it to **Secretary, National Foundation for Communal Harmony, 9th floor, 'C' Wing, Lok Nayak Bhawan, Khan Market, New Delhi-110003** through Registered/Speed Post and **not** by courier.
