- 4. Utilisation Certificate and Statement of Expenditure should be submitted towards the released amount of sanction.

Further installment will be released after project report review, due credentials should be given to GSBB in all knowledge materials created as outcome of this project, learnings of this project should be made available to GSBB for larger benefit of public & State. All type of cooperation to GSBB and it's representatives is expected on ground during all the phases of the project.
